1. Applications will be accepted between March 15 – May 15 of the year prior to desired enrollment.
2. Stallion must be living at time of enrollment.
3. Enrollment applications will be accepted from the current stallion owner only.
4. The total annual enrollment fee will be \$2800. The nonrefundable nomination fee of \$500 is due with this application. If the stallion is accepted into the program, the balance of \$2300 and a signed FF stallion contract will be due no later than September 1.
5. A copy of the stallion's breed registrations papers showing current ownership must be included with the application.
6. Stallion owner must provide official breed stallion report(s) indicating that the stallion has been bred to a minimum of 25 mares in the stallion's lifetime. These documents must be submitted with the enrollment application.
7. A \$500 nonrefundable nomination fee must be submitted with the enrollment application. If the stallion is not accepted into the FF program, this fee will be refunded.
8. Future Fortunes, Inc. reserves the right to refuse enrollment to any stallion.
9. If a stallion owner drops the stallion from the program for any reason, the stallion will not be eligible for re-enrollment.
